STEP 1

Read and understand all steps in the instructions before starting the installation. Park the motorcycle on a hard, level surface and turn off the ignition. Let motorcycle cool.

PREVENT SERIOUS INJURIES AND/OR DEATH! NEVER EXCEED THE MANUFACTURER'S RECOMMENDED LOAD LIMITS FOR YOUR MOTORCYCLE! BE SURE THE SADDLEBAGS DO NOT COME INTO CONTACT WITH ANY MOVING PARTS. ALWAYS **CHECK FOR PROPER CLEARANCE BEFORE RIDING!**

MOUNTING SUGGESTIONS

- The saddlebags fit either over or under the passenger seat.
- Use the adjustable straps and the hook & loop straps to secure the saddlebags to your motorcycle. DO NOT secure the saddlebags to the swingarm or any other part that moves independently from the seat. Be sure that the straps will not become tangled in any moving parts before riding.
- The saddle strap between the tops of the saddlebags is adjustable, allowing the bags to fit many applications. Loosen the saddle strap lace, adjust and retighten as necessary to properly fit your application. Be sure that the width between the saddlebags is not so loose that a saddlebag could get caught under the fender or in the wheel. Always check for proper clearance before riding. Allow for at least 4" of clearance from exhaust pipes.
- The saddlebags are equipped with multiple steel D-rings allowing you to get the best fit for your application. Slide the steel D-rings into the elastic pockets when not in use to eliminate rattling due to vibration.



▲ WARNING

AFTER INSTALLING THE SADDLEBAGS, BE SURE TO CHECK FOR PROPER CLEARANCE BETWEEN THE BAG AND ANY MOVING PARTS, INCLUDING THE WHEELS AND SWING ARM. NEVER PLACE THE ACHORING STRAPS NEAR THE WHEELS OR BRAKE CALIPERS. BE SURE THE PLACEMENT OF THE SADDLEBAGS DOES NOT INTERFERE WITH SAFE OPERATION OF THE MOTORCYCLE.

NOTICE

THE SADDLEBAGS HAVE HEAT-RESISTANT SHIELDS BUT WE DO NOT RECOMMEND PLACING THE BAGS NEAR EXHAUST PIPES. BE SURE TO MAINTAIN PROPER CLEARANCE AWAY FROM EXHAUST PIPES. ALLOW AT LEAST 4" CLEARANCE FROM **EXHAUST PIPE.**
